2nd Violation: A uniform violation letter and a call to the parent(s) from the teacher.
$3^{\text {rd }} \quad$ Violation: A uniform violation letter and a call to the parent(s) from the Principal.

Violation: Parents will be required to come in for a conference with the school administration, and the student's enrollment will be placed on probation. Further Violation of the School Contract uniform component will result in the student returning to his/her home school
